We have approved your request dated April 22, 2016, to supplement your Biologics License Application (BLA) submitted under section 351(a) of the Public Health Service Act (42 U.S.C. 262) for Varicella Virus Vaccine Live (VARIVAX®) manufactured at your West Point, PA (b) (4) facilities to include implementation of the (b) (4) method in the production of Varicella Zoster Virus (b) (4) for VARIVAX® Drug Substance manufacture.

We have also approved revisions to your package insert labeling to comply with the 2014 Final Rule, *Content and Format of Labeling for Human Prescription Drug and Biological Products; Requirements for Pregnancy and Lactation Labeling.*

All promotional claims must be consistent with and not contrary to approved labeling. You should not make a comparative promotional claim or claim of superiority over other products unless you have substantial evidence or substantial clinical experience to support such claims (21 CFR 202.1(e)(6)).

Please submit an amendment to all pending supplemental applications for this BLA that include revised labeling incorporating a revised content of labeling that includes these changes.

We will include information contained in the above-referenced supplement in your BLA file.
