Instructions: The time lapse from departure to arrival cannot exceed 9 hours as long as sea and air temperatures do not exceed 83 °F. The time lapse from departure to arrival cannot exceed 6 hours if sea or air temperatures exceed 83 °F during any point of time lapse. If temps are approaching 83 °F before the last boat is in, check and record temps more frequently. Internal temperatures, sensory evaluations, and lot numbers are recorded on separate QC Receiving record.
