We have approved your request dated March 19, 2018, to supplement your Biologics License Application (BLA) submitted under section 351(a) of the Public Health Service Act (42 U.S.C. 262) for Zoster Vaccine Recombinant, Adjuvanted (SHINGRIX), manufactured at your (b) (4), Belgium location, to include revisions to the package insert regarding the vial descriptions and other minor changes.

### LABELING

All final labeling should be submitted as Product Correspondence to this BLA STN 125614 at the time of use (prior to marketing) and include implementation information on Form FDA 356h.

All promotional claims must be consistent with and not contrary to approved labeling. You should not make a comparative promotional claim or claim of superiority over other products unless you have substantial evidence or substantial clinical experience to support such claims (21 CFR 202.1(e)(6)).

Please submit an amendment to all pending supplemental applications for this BLA that include revised labeling incorporating a revised content of labeling that includes these changes.

We will include information contained in the above-referenced supplement in your BLA file.
