## **Change Description**

Previously, the "Getting Started" dialog was missing instructions on transferring working files originally created within FDA eSubmitter so that they could be reused within CVM eSubmitter. Specifically, contact and address information, as well as previously created submissions that could be reused to create new submissions in CVM eSubmitter through the "Save-As" operation.

With the latest change, we have inserted a new Step 3: "Retaining FDA eSubmitter Content for Use in CVM eSubmitter."
