# 1. Authority Delegated and To Whom Delegated.

- A. The officials listed below are authorized to perform all the functions of the Commissioner of Food and Drugs pursuant to the Federal Food, Drug, and Cosmetic Act (21 U.S.C. 379(c)(3)) Section 708(c)(3). Such officials may disclose such information directly or may authorize such disclosure and designate agency members to transmit such information to the foreign government on the official's behalf whether for an individual disclosure or a series of disclosures at the discretion of the official.
