Dear Mr. Stirr:

We have approved your request submitted and received on September 20, 2019, to supplement your Biologics License Application (BLA) under section 351(a) of the Public Health Service Act for Typhoid Vi Polysaccharide Vaccine (Typhim Vi), manufactured at your facility located in (b) (4), to include updates to the product labeling (package insert, carton and container) to revise the Description, Precautions, Dosage and Administration and How Supplied sections.

LABELING

We hereby approve the draft package insert labeling submitted under amendment 2, dated March 11, 2020, and the draft carton and container labeling submitted under amendment 1, dated February 26, 2020.

CONTENT OF LABELING

The SPL will be accessible via publicly available labeling repositories.

PACKAGE AND CONTAINER LABELS

Please electronically submit final printed package and container labels that are identical to the package and container labels submitted on February 26, 2020, according to the guidance for industry *Providing Regulatory Submissions in Electronic Format — Certain Human Pharmaceutical Product Applications and Related Submissions Using the eCTD Specifications* at <https://www.fda.gov/regulatory-information/search-fda-guidance-documents/providing-regulatory-submissions-electronic-format-certain-human-pharmaceutical-product-applications>.

All final labeling should be submitted as Product Correspondence to this BLA 103936 at the time of use (prior to marketing) and include implementation information on Form FDA 356h.

ADVERTISING AND PROMOTIONAL LABELING

You may submit two draft copies of the proposed introductory advertising and promotional labeling with Form FDA 2253 to the Advertising and Promotional Labeling Branch at the following address:

You must submit copies of your final advertising and promotional labeling at the time of initial dissemination or publication, accompanied by Form FDA 2253 (21 CFR 601.12(f)(4)).

All promotional claims must be consistent with and not contrary to approved labeling. You should not make a comparative promotional claim or claim of superiority over other products unless you have substantial evidence or substantial clinical experience to support such claims (21 CFR 202.1(e)(6)).

Please submit an amendment to all pending supplemental applications for this BLA that include revised labeling incorporating a revised content of labeling that includes these changes.

We will include information contained in the above-referenced supplement in your BLA file.
