Dear Dr. Honigfort:

The purpose of this letter is to confirm that The Chemours Company (the "Company") has never introduced into United States interstate commerce or delivered for introduction into United States interstate commerce, and will not hereafter introduce into United States interstate commerce or deliver for introduction into United States interstate commerce, the food contact substance (FCS) authorized by Food Contact Notification (FCN) No. 940 for any use in food contact applications subject to the jurisdiction of the United States Food and Drug Administration (FDA). This FCN was originally notified by DuPont Chemical Solutions Enterprise (a predecessor in interest to Chemours) for use as an oil and grease resistant treatment for paper and paperboard.

As of June 1, 2019, the notifier ceased sales of the FCS outside of the United States. Based upon The Company's experience, it is expected that the large majority of any existing global stocks of the neat FCS, paper and paperboard coated with it, and food packaged in paper coated with it, held by companies further down the supply chain from the Company will be exhausted within one-year of the cessation of commerce outside of the United States (*e.g.*, June 1, 2020).

The Company acknowledges that FDA may, in its discretion, amend the Inventory of Effective Food Contact Notifications with respect to the FCN listed above in any manner deemed appropriate by the Agency to reflect the commitments of this letter.
