## 1. BACKGROUND

### **1.1. NEW AND PREDICATE PRODUCTS**

The applicant submitted information for the new and predicate products listed in detail in the Appendix.

### **1.3. SCOPE OF REVIEW**

This review captures all compliance, regulatory, and scientific reviews completed for the new products that are the subject of this review.

#### **2. COMPLIANCE REVIEW**

The Office of Compliance and Enforcement (OCE) completed reviews to determine whether the applicant established that the predicate products are grandfathered products (i.e., were commercially marketed in the United States as of February 15, 2007). The OCE reviews dated October 11, 2021<sup>1</sup>, conclude that the evidence submitted by the applicant is adequate to demonstrate that the predicate products are grandfathered and, therefore, are eligible predicate products.

OCE also completed reviews to determine whether the new products are in compliance with the Federal Food, Drug, and Cosmetic Act (FD&C Act) (see section 910(a)(2)(A)(i)(II) of the FD&C Act). The OCE reviews dated November 2, 2021, conclude that the new products are in compliance with the FD&C Act.

## **3. SCIENTIFIC REVIEW**

Full scientific review was not initiated by the Office of Science (OS) because the product characteristics of the new and corresponding predicate tobacco products are identical except for the following change in product quantity:

OS prepared memoranda<sup>2</sup> summarizing its current thinking on product quantity changes. Existing data on product quantity changes are limited and do not address the size threshold (i.e., how much of a change in product quantity) necessary to raise different questions of public health. With respect to product quantity decreases, even though some of the currently available scientific evidence is specific to tobacco products, the studies do not separate out the effect of reduced price from size on consumption or initiation. Thus, based upon the currently available science and CTP's experience in reviewing SE Reports, product quantity changes do not cause new tobacco products to raise different questions of public health. Therefore, scientific review is unnecessary.

### 4. ENVIRONMENTAL DECISION

The final environmental review found the applicant did not provide current year market volume information for the predicate products. Additionally, for SE0018372 confidential appendices containing market volume, manufacturer, and packaging information were not included. This information is needed to evaluate environmental impacts of the new and predicate products. Therefore, additional information is needed to determine whether to prepare an Environmental Impact Statement (EIS) or Finding of No Significant Impact (FONSI).

#### 5. CONCLUSION AND RECOMMENDATION

The product characteristics of the new and corresponding predicate products are identical except for an increase in product quantity from 1 cigar wrapper to 2 cigar wrappers.

The OS memoranda concludes that based on OS' experience and the currently available evidence, the difference in product quantity does not cause the new tobacco products to raise different questions of public health. I concur with this conclusion.

The predicate products meet statutory requirements because it was determined that they are grandfathered products (i.e., were commercially marketed in the United States as of February 15, 2007).

The new products are currently in compliance with the FD&C Act.

FDA examined the environmental effects of finding these new products substantially equivalent and found additional information is necessary to determine the impact of the action. Without this information, FDA is precluded from issuing an SE order.

An Environmental Information Request letter should be issued requesting the following information:

1. All of your SE Reports do not provide current year market volume information for the predicate products. This information is needed to evaluate environmental impacts of the new and predicate products. In the table to follow, provide current year market volumes and associated weights in metric tons for all predicate products.

This information is needed to evaluate environmental impacts of the new and predicate products. Provide Confidential Appendices 1, 2, and 3 for SE0018372.

If the applicant adequately responds to the request and an EIS or FONSI is completed, SE order letters should be issued for the new products, as identified in the Appendix of this review.
