Dear Mr. Stirr:

We have approved your request received on August 11, 2022, to supplement your Biologics License Application (BLA) submitted under section 351(a) of the Public Health Service Act for Meningococcal (Groups A, C, Y, W) Conjugate Vaccine (MenQuadfi) manufactured at your Swiftwater, PA facility to include safety and effectiveness data from clinical studies MET59 and MEQ66 in support of booster vaccination of individuals 13 years of age and older who are at continued risk for meningococcal disease if at least 3 years have elapsed since a prior dose of meningococcal (groups A, C, W, Y) conjugate vaccine, and vaccination following a prior dose of meningococcal polysaccharide vaccine if at least 3 years have elapsed since the prior dose of meningococcal polysaccharide vaccine.

The review of this supplement was associated with the following National Clinical Trial (NCT) numbers: NCT04084769 and NCT04142242.

LABELING

You must submit copies of your final advertising and promotional labeling at the time of initial dissemination or publication, accompanied by Form FDA 2253 (21 CFR 601.12(f)(4)).

All promotional claims must be consistent with and not contrary to approved labeling. You should not make a comparative promotional claim or claim of superiority over other products unless you have substantial evidence or substantial clinical experience to support such claims (21 CFR 202.1(e)(6)).

Please submit an amendment to all pending supplemental applications for this BLA that include revised labeling incorporating a revised content of labeling that includes these changes.

We will include information contained in the above-referenced supplement in your BLA file.
