About OMDRHO

The Office of Medical Device and Radiological Health Operations (OMDRHO) coordinates, directs, and assists with medical device and radiological health inspectional activities, including conducting inspections of medical device and radiation-emitting products.

OMDRHO's mission is to protect consumers/patients and enhance public health by ensuring timely access to safe, quality FDA-regulated products.

What is a Consumer Safety Officer?

A Consumer Safety Officer (CSO) in OMDRHO is responsible for conducting inspections and investigations of medical device firms, and submitting inspection reports with supporting evidence documenting violations of the laws we enforce.

What are the CSO Qualifications?

A bachelor's or graduate/higher level degree in quality assurance or a related degree that includes at least 30 semester hours in one or a combination of the following: consumer laws, biological sciences, food science, chemistry, pharmacy, physical sciences, food technology, nutrition, medical science, engineering, epidemiology, veterinary medical science, legal investigations, law enforcement, or related scientific fields. The 30 semester hours may include up to 8 semester hours in statistics, or course work that included the principles, theory, or practical application of computers or computer programming.

OR - A combination of education and experience--courses consisting of at least 30 semester hours in the fields of study above, plus appropriate experience or additional education.
