We have approved your request received April 17, 2023, to supplement your Biologics License Application (BLA) submitted under section 351(a) of the Public Health Service Act for onasemnogene abeparvovec-xioi to update the Warnings and Precautions and Patient Counseling Information sections of the US Prescribing Information for ZOLGENSMA® (onasemnogene abeparvovec-xioi) to include potential risks of tumorigenicity due to adeno-associated virus (AAV) vector integration.

LABELING

The SPL will be accessible via publicly available labeling repositories.

All final labeling should be submitted as Product Correspondence to this BLA, STN BL 125694/0 at the time of use and include implementation information on Form FDA 356h.

You must submit copies of your final advertising and promotional labeling at the time of initial dissemination or publication, accompanied by Form FDA 2253 (21 CFR 601.12(f)(4)).

All promotional claims must be consistent with and not contrary to approved labeling. You should not make a comparative promotional claim or claim of superiority over other products unless you have substantial evidence or substantial clinical experience to support such claims (21 CFR 202.1(e)(6)).

We will include information contained in the above-referenced supplement in your BLA file.
