
### 1. Office of Budget, Facilities and Travel Support (DCSBA).

- A. Provides overall guidance and strategic planning for all aspects of Office of Inspections and Investigations (OII) financial management for senior leaders. This includes budget execution, acquisitions, and budget formulation.
- B. Provides guidance related to Office of Management and Budget (OMB), Government Accountability Office (GAO), and Office of the Inspector General (OIG) financial inquiries to include statutes, regulations, policies, procedures, and instructions in coordination with the Office of Operations (OO).
- C. Consults on all contracting and acquisition actions for OII to include cooperative agreements, contracts, and grants.
- D. Coordinates the OII's annual budget estimates through the Office of Operations for review by the Department of Health and Human Services (HHS), OMB, and Congress.
- E. Provides overall strategic leadership and guidance to OII on all aspects of travel in accordance with established guidelines.
- F. Provides leadership and guidance to OII on all aspects of field facilities, physical security, safety management, and property management activities in accordance with established guidelines in coordination with the OO.

#### 2. Authority and Effective Date.

The functional statements for the Office of Budget, Facilities and Travel Support were approved by the Secretary of Health and Human Services on March 5, 2024, and effective on May 13, 2024.
