## **Division of Import Business Informatics and Solutions**

Effective Date: May 13, 2024

### 1. Division of Import Business Informatics and Solutions (DCSFB).

- A. Manages operational business solutions supporting the Import Program operational activities of the Office of Inspections and Investigations (OII).
- B. Partners with the Office of Digital Transformation (ODT) to plan, implement, operate, and maintain solutions that support the Imports Program for OII as well as integrate such solutions with other Food and Drug Administration (FDA) Centers, Offices, and State regulatory and public health agency solutions.
- C. Serves as a liaison to the ODT and the Department of Health and Human Services (HHS) for the business requirements and functionality, and works with ODT and contractors on design, development, application, and implementation of operational business solutions supporting the Import Program; analyzes, reviews, and makes recommendations for modifications to existing solutions; and proposes new business solutions to meet OII and its customers' requirements.
- D. Provides a customer-oriented support center, technical assistance and business process re-engineering activities for OII business solutions supporting Import operations.
- E. Develops scope of work and contractual mechanisms for execution of OII business solution projects supporting the Import Program working in conjunction with business sponsors, the Office of Acquisition and Grants (OAGS) and ODT.

## 2. Import Business Informatics Branch (DCSFB1).

- A. Provides official responses and ad hoc reports in response to data requests associated with data stored in OII Import solutions.
- B. Provides technical assistance and training to OII staff associated with the generation of data and creation of reports associated with data stored in OII Import solutions.
- C. Assists business in managing data stored in OII solutions natively or received from other systems through analysis of data quality and recommending solutions to resolve or to improve data quality of data stored in systems supporting the Import Program.
- D. Engages with the development and enhancement of solutions to be aware of policies that drive data collection, data exchange implementations, changes to data content, and changes to data modeling, and to advise on and have awareness of development to conduct data reporting and analysis.
- E. Facilitates implementation of best practices for data collection, data exchange, querying, and governance of data structures in OII solutions supporting the Import Program.


### 3. Import Business Solutions Branch (DCSFB2).

- A. Serves as business leads and subject matter experts for OII solutions supporting Import activities and processes.
- B. Conducts joint business planning with OII, Centers, and Office stakeholders to systematically assess and prioritize business needs for new functionality associated with Import activities.
- C. Ensures processes and resources are in place to build, deploy, and support solutions supporting Import activities.
- D. Supports adherence to policies and procedures for Import program operations through business process analysis and solutions development activities.

#### 4. Authority and Effective Date.

The functional statements for the Division of Import Business Informatics and Solutions were approved by the Secretary for Health and Human Services on March 5, 2024, and effective on May 13, 2024.
