1. Office of Human Food Inspectorate. (DCSK).


- A. Leads Office Directors in the coordination, interpretation, and evaluation of the Food and Drug Administration's (FDA) overall field inspections efforts in the areas of domestic and foreign human food and other products regulated by the Human Foods Program (HFP).
- B. Provides direction and guidance to the Office of Inspections and Investigations (OII) leaders and other senior FDA leaders on human food inspection and other field activities.
- C. Coordinates human food operations with the Deputy Commissioner for Human Foods and HFP Offices.
- D. Supports human food partnerships and inspectorate policy through collaboration with the Integrated Food Safety Systems Partnerships office in the HFP.
- E. Evaluates the overall management and capabilities of the FDA's human food field organization and initiates action to improve the management of global human food field activities.
- F. In collaboration with the FDA HFP, Centers, and offices, establishes inspection goals that align with the resource capacity of OII.
- G. Coordinates human food quality system activities and coordinates work planning and maintenance of the official establishment inventory with HFP.
- H. Develops, issues, and approves proposals and instructions affecting global human food field operations.

- I. Develops, clears, issues, and maintains guidance to the field in the investigation's operations manual relative to human food.
- J. Promotes the need for prompt and positive action within the FDA to assure safe human food products.
- K. Coordinates with the Office of Emergency Response to support HFP for emergency preparedness and response activities relative to human food.
- L. Participates, where appropriate, in international cooperation activities relative to human food.
- M. Review responses to FDA Form 483 and issues FMD-145s for NAI inspections, and a portion of VAI inspections, in coordination with the HFP, Centers, and offices.

2. Authority and Effective Date.

The functional statements for the Office of Human Food Inspectorate were approved by the Secretary of Health and Human Services on March 5, 2024, and effective on May 13, 2024.
