1. Division of Additives and Ingredients (DCRKBB).

- A. Manage and conduct post-market safety assessments of all food chemicals and dietary supplement ingredients.
- B. Manage and conduct post-market safety assessments for all abandonment and revocation color additive petitions, food additive petitions, and citizen petitions.
- C. Develop and apply the suite of tools to perform systematic post-market review that includes in silico and new approach methods suitable for supporting post-market food chemical safety assessment activities.
- D. Support the use of predictive tools for supporting pre- and post-market food chemical safety assessment; and supporting the data analytics needs of the Office of Food Chemical Safety, Dietary Supplements, and Innovation.
- E. Develops and directs, as necessary, policies, guidance, compliance efforts, obtains necessary information and data, and takes appropriate regulatory action based on post-market assessment to implement relevant provisions of the Federal Food, Drug, and Cosmetic Act specific to chemicals in food and dietary supplements.

2. Hazard Assessment and Analytics Branch (DCRKBB1).

A. Develops and applies the suite of tools to perform systematic post-market review that includes in silico and new approach methods suitable for supporting post-market food chemical safety assessment activities.

B. Supports the use of predictive tools for supporting pre- and post-market food chemical safety assessment; and supporting the data analytics needs of the Office of Food Chemical Safety, Dietary Supplements, and Innovation.


3. Regulatory Management Branch (DCRKBB2).

- A. Manages and conduct post-market safety assessments of all food chemicals and dietary supplement ingredients.
- B. Manages and conduct post-market safety assessments for all abandonment and revocation color additive petitions, food additive petitions, and citizen petitions.
- C. Develops and directs, as necessary, policies, guidance, compliance efforts, obtains necessary information and data, and takes appropriate regulatory action based on post-market assessment to implement relevant provisions of the Federal Food, Drug, and Cosmetic Act specific to chemicals in food and dietary supplements.

4. Authority and Effective Date.

The functional statements for the Division of Additives and Ingredients were approved by the Secretary of Health and Human Services on March 5, 2024, and effective on May 13, 2024.
