Research Activity

Research Activities

My research focuses on the epidemiology of aging with a specific interest in patients with end stage kidney disease. In particular, I seek to better understanding how novel metrics of aging, like frailty and cognitive function, can improve risk prediction in kidney transplant recipients and patients undergoing hemodialysis. I am also currently conducting a 2-by-2 factorial RCT to identify interventions to preserve cognitive function among patients initiating hemodialysis. I study the impact of medications on age-related outcomes among patients with end-stage kidney disease using national registry data linked to Medicare claims. Finally, I have a new project to better understand the intersection of health equity and cognitive aging in ESKD and KT. I am in the process of planning a new cohort study to measure visual acuity in older kidney transplant candidates and recipients, testing whether vision impairment impacts pre- and post-transplant cognitive decline.
