We have approved your request received May 6, 2024, to supplement your Biologics License Application (BLA) submitted under section 351(a) of the Public Health Service Act for Measles, Mumps, and Rubella Virus Vaccine Live (M-M-R II), manufactured at your West Point, Pennsylvania and (b) (4) locations, to revise the Package Insert to include information on a case of Congenital Rubella Syndrome following inadvertent vaccination of a pregnant woman with a measles, mumps, and rubella virus containing vaccine from an unknown manufacturer.

## **LABELING**

We hereby approve the draft content of labeling: Package Insert submitted under amendment 2, dated October 29, 2024.

## **CONTENT OF LABELING**

Content of labeling must be identical to the Package Insert submitted on October 29, 2024. The SPL will be accessible via publicly available labeling repositories.

All final labeling should be submitted as Product Correspondence to this BLA, STN BL 101069, at the time of use and include implementation information on Form FDA 356h.

You must submit copies of your final advertising and promotional labeling at the time of initial dissemination or publication, accompanied by Form FDA 2253 (21 CFR 601.12(f)(4)).

All promotional claims must be consistent with and not contrary to approved labeling. You should not make a comparative promotional claim or claim of superiority over other products unless you have substantial evidence or substantial clinical experience to support such claims (21 CFR 202.1(e)(6)).

For each pending supplemental application for this BLA that includes proposed revised labeling, please submit an amendment to update the proposed revised labeling with the change approved today.

We will include information contained in the above-referenced supplement in your BLA file.
