## 1. Division of Employee Training and Development (DCCEFA).

- A. Collaboratively develops the Center for Devices and Radiological Health (CDRH) Strategic Training and Education Plan.
- B. Manages CDRH training budget to ensure the Center can meet its mission and goals.
- C. Determine Center-wide training and development needs.
- D. Implements and manages the Center's Strategic Training and Education Plan to ensure all employees have adequate access to courses and programs related to science, regulatory law, leadership, and professional development.
- E. Identifies the appropriate modality for training content based on adult learning theory and the principles of instructional systems design.
- F. Develops CDRH-specific training content in the disciplines of science, regulatory law, leadership and professional development.
- G. Manages the Center's training programs from administration through implementation and evaluation.
- H. Coordinates with external partners to provide CDRH staff with access to additional training opportunities.
- Manages the Center's compliance with mandatory training at the Center, Food and Drug Administration (FDA) and Department of Health and Human Services (HHS) levels.
- J. Responds to individual, team, division, and office requests for training to help meet their missions and goals.

- K. Provides consultative services in adult learning theory and instructional system design, and training delivery methodologies.
- L. Administers the evaluation and analysis of training at the Center-level, including implementing modifications in response to evaluation results.
- M. Manages and maintains the Center's training data through the learning management system.
- N. Implements and adheres to training regulations, policies and procedures.
