
#### 1. Center for Veterinary Medicine (DCG).

- A. Develops and recommends the policy of the Food and Drug Administration (FDA) with respect to the safety and effectiveness of animal drugs, feeds, feed additives; veterinary medical devices (medical devices for animal use); other veterinary medical products; and in cooperation with other FDA components, provides policy development and direction on environmental impact matters.
- B. Evaluates, for animal safety and effectiveness, and other criteria as appropriate, proposed and marketed animal products including drugs in pharmaceutical dosage forms and animal feed; animal cell- and tissue-based and gene therapy products; intentional genomic alterations to animals; feed additives; and marketed veterinary medical devices.
- C. Coordinates the veterinary medical aspects of FDA inspectional and investigational programs and provides veterinary medical opinions in drug hearings and court cases.
- D. Plans, directs, and evaluates the FDA's surveillance and compliance programs relating to animal drugs, feeds, feed additives, veterinary medical devices, and other veterinary medical products.

#### 2. Authority and Effective Date.

The functional statements for the Center for Veterinary Medicine Center were approved by the Secretary of Health and Human Services on July 22, 2024, and effective on August 23, 2024.
