#### **AUTHORITY TO APPROVE PAYMENT OF SUPERVISORY DIFFERENTIALS**

Effective Date: December 9, 2015

## 1. AUTHORITY DELEGATED AND TO WHOM DELEGATED

- A. The following officials are authorized to approve new or increase existing supervisory differential amounts and to approve the reduction or termination of supervisory differentials for both mandatory and non-mandatory actions:
  - 1. Deputy Commissioners
  - 2. Associate Commissioners
  - 3. Chief Counsel and Deputy Chief Counsels
  - 4. Chief Scientist
  - 5. Center Directors and Deputy Center Directors
  - 6. Deputy Center Director for Management Services, National Center for Toxicological Research (NCTR)
  - 7. Associate Director, Office of Management Services, NCTR
  - 8. Director, Office of Management, Center for Biologics Evaluation Research (CBER)
  - 9. Director, Office of Management, Center for Drug Evaluation Research (CDER)
  - 10. Associate Director for Management, Center for Devices and Radiological Health (CDRH)
  - 11. Director, Office of Management Center for Tobacco Products (CTP)
  - 12. Associate Director for Management Center for Food Safety and Applied Nutrition (CFSAN)

- 13. Director, Office of Management Center for Veterinary Medicine (CVM)
- 14. Director, Office of Resource Management, Office of Regulatory Affairs (ORA)
- 15. ORA Regional Food and Drug Directors and District Directors
- 16. Deputy Chief Operating Officer, Office of Operations (OO)
- 17. Director, Office of Human Resources, OO
- B. The following officials are authorized to recommend new, or increase existing, supervisory differential amounts and to recommend the reduction or termination of supervisory differentials for both mandatory and non-mandatory actions:
  - 1. Officials who are one level below the official indicated in 1.A. above.

## 2. LIMITATIONS

The total continuing pay of the supervisor receiving the differential may not exceed the total continuing pay of the highest paid non-GS subordinate employee by more than 3%.

#### 3. REDELEGATION.

The authorities delegated in 1.B. may be further re-delegated; however, the approving official in 1.A. must be a higher level official than the recommending official in 1.B.

## 4. EFFECTIVE DATE.

The Deputy Commissioner for Operations and Chief Operating Officer approved this delegation, via memorandum, on December 9, 2015.
