We are writing to request your assistance with much-needed efforts to reduce injuries and deaths associated with the use of adult portable bed rails. Incident reports received by the U. S. Consumer Product Safety Commission (CPSC) indicate that adult portable bed rails currently on the market are associated with a substantial number of injuries and deaths among users, particularly the elderly. Specifically, CPSC staff is aware of 160 tragic incidents between 2003 and 2012 alone that involved entrapments, entanglements, or strangulations in bed rails. Of these 160 reported incidents, 155 resulted in fatalities. Additionally, seven death reports associated with portable bed rails were submitted to FDA's Manufacturer and User Facility Device Experience (MAUDE) database from 2005 through 2012.

Considering the number of deaths and injuries, we strongly believe all reasonable and timely efforts should be undertaken to address this hazard and protect the safety of the public. Currently, there are no mandatory or voluntary product safety standards for adult portable bed rails.² This must change.

At the request of CPSC and FDA, ASTM International is forming a committee to develop a new voluntary standard for adult portable bed rails. If your company or organization has not already committed to join this process and participate in the development of a consensus-based, voluntary industry standard to address the hazards associated with the use of adult portable bed rails, we request that you do so.

It is our understanding that ASTM has set a meeting on this topic. This meeting is scheduled for **Wednesday**, **June 19, 2013**, **at 2:00 pm (EST)** and will be held via the web through Webex, an

² The ASTM International (ASTM) voluntary standard for portable bed rails, ASTM F 2085, Standard Consumer Safety Specification for Portable Bed Rails defines a "portable bed rail" as a device intended to be installed on an adult bed to prevent children from falling out of bed. These bed rails are intended for children who can get in and out of an adult bed unassisted, typically ranging in age from two to five years old. However, this standard is not intended to address the risks associated with the use of adult portable bed rails.
